**2. Hazards Identification**

**Emergency overview** Aerosol. CONTENTS UNDER PRESSURE.  
**Potential health effects**  
**Routes of exposure** Ingestion.  
**Eyes** Health injuries are not known or expected under normal use.  
**Skin** Frequent or prolonged contact may defat and dry the skin, leading to discomfort and dermatitis.  
**Inhalation** Intentional misuse by concentrating and inhaling the product can be harmful or fatal.  
**Ingestion** Exposure by ingestion of an aerosol is unlikely. Components of the product may be absorbed into the body by ingestion.  
**Target organs** 2-Butoxy ethanol may be absorbed through the skin in toxic amounts if contact is repeated and prolonged and may cause blood damage. These effects have not been observed in humans.

**Chronic effects** Unconsciousness. Cyanosis (blue tissue condition, nails, lips, and/or skin). May be harmful if absorbed through skin. May cause central nervous system disorder (e.g., narcosis involving a loss of coordination, weakness, fatigue, mental confusion and blurred vision) and/or damage. May cause delayed lung injury.  
**Signs and symptoms** Discomfort in the chest. Narcosis. Cyanosis (blue tissue condition, nails, lips, and/or skin). Coughing. Jaundice. Defatting of the skin. Skin irritation.

**4. First Aid Measures**

**First aid procedures**  
**Eye contact** Immediately flush eyes with plenty of water for at least 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing.  
**Skin contact** Immediately take off all contaminated clothing. Wash off with warm water and soap. Get medical attention if irritation develops and persists.  
**Inhalation** If inhalation of gas/fume/vapor/dust/mist from the material is excessive (air concentration is greater than the TLV or health effects are noticed), immediately remove the affected person(s) to fresh air. Call a physician if symptoms develop or persist.  
**Ingestion** If ingestion of a large amount does occur, call a poison control center immediately.

## 5. Fire Fighting Measures

<b>Flammable properties</b>	Heat may cause the containers to explode. Vapor or gas may spread to distant ignition sources and flash back. Runoff to sewer may cause fire or explosion hazard.
<b>Extinguishing media</b>	
<b>Suitable extinguishing media</b>	Water fog. Foam. Dry chemical powder. Carbon dioxide (CO2).
<b>Protection of firefighters</b>	
<b>Protective equipment and precautions for firefighters</b>	In case of fire and/or explosion do not breathe fumes. Containers should be cooled with water to prevent vapor pressure build up. Move containers from fire area if you can do so without risk. Cool containers exposed to flames with water until well after the fire is out. For massive fire in cargo area, use unmanned hose holder or monitor nozzles, if possible. If not, withdraw and let fire burn out.

## 6. Accidental Release Measures

<b>Methods for containment</b>	Stop leak if you can do so without risk. Move the cylinder to a safe and open area if the leak is irreparable. Stop the flow of material, if this is without risk.
<b>Methods for cleaning up</b>	Should not be released into the environment. Use a non-combustible material like vermiculite, sand or earth to soak up the product and place into a container for later disposal.  Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

## 7. Handling and Storage

<b>Handling</b>	Pressurized container: Do not pierce or burn, even after use. Do not smoke while using or until sprayed surface is thoroughly dry. Do not use if spray button is missing or defective. Do not re-use empty containers. Avoid contact with skin. Avoid contact with eyes. Avoid prolonged exposure.
<b>Storage</b>	Contents under pressure. Do not puncture, incinerate or crush. The pressure in sealed containers can increase under the influence of heat. Do not handle or store near an open flame, heat or other sources of ignition. Avoid exposure to long periods of sunlight. Store in cool place. Store in a well-ventilated place. Keep out of the reach of children. Keep away from food, drink and animal feedingstuffs. Level 1 Aerosol (NFPA 30B)
