**2. Hazards Identification**

**Emergency overview** Aerosol. CONTENTS UNDER PRESSURE.  
 Prolonged exposure may cause chronic effects. May be ignited by heat, sparks or flames.

**Potential health effects**

- Routes of exposure** Skin contact. Ingestion.
- Eyes** Health injuries are not known or expected under normal use.
- Skin** May be harmful if absorbed through skin. Frequent or prolonged contact may defat and dry the skin, leading to discomfort and dermatitis.
- Inhalation** Intentional misuse by concentrating and inhaling the product can be harmful or fatal.
- Ingestion** Exposure by ingestion of an aerosol is unlikely. Components of the product may be absorbed into the body by ingestion.

**Target organs** 2-Butoxy ethanol may be absorbed through the skin in toxic amounts if contact is repeated and prolonged and may cause blood damage. These effects have not been observed in humans.

**Chronic effects** Unconsciousness. Cyanosis (blue tissue condition, nails, lips, and/or skin). May be harmful if absorbed through skin. Liver injury may occur. Kidney injury may occur. Frequent or prolonged contact may defat and dry the skin, leading to discomfort and dermatitis.

**Signs and symptoms** Cyanosis (blue tissue condition, nails, lips, and/or skin). Liver enlargement. Jaundice. Defatting of the skin. Skin irritation.

**4. First Aid Measures**
**First aid procedures**

**Eye contact** Immediately flush eyes with plenty of water for at least 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Get medical attention if irritation develops or persists.

**Skin contact** Immediately take off all contaminated clothing. Wash off with warm water and soap. Get medical attention if irritation develops and persists.

**Inhalation**

If symptoms develop move victim to fresh air. Get medical attention if symptoms occur.

**Ingestion**

If vomiting occurs, keep head low so that stomach content doesn't get into the lungs. If ingestion of a large amount does occur, call a poison control center immediately.

**Notes to physician**

In case of shortness of breath, give oxygen. Keep victim warm. Keep victim under observation.

### 5. Fire Fighting Measures

**Flammable properties**

Heat may cause the containers to explode. Vapor or gas may spread to distant ignition sources and flash back. Runoff to sewer may cause fire or explosion hazard.

**Extinguishing media**

**Suitable extinguishing media**

Water fog. Foam. Dry chemical powder. Carbon dioxide (CO2).

**Protection of firefighters**

**Protective equipment and precautions for firefighters**

In case of fire and/or explosion do not breathe fumes. Containers should be cooled with water to prevent vapor pressure build up. Move containers from fire area if you can do so without risk. For massive fire in cargo area, use unmanned hose holder or monitor nozzles, if possible. If not, withdraw and let fire burn out.

### 6. Accidental Release Measures

**Methods for containment**

ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). Stop the flow of material, if this is without risk. Prevent entry into waterways, sewer, basements or confined areas.

**Methods for cleaning up**

Should not be released into the environment.

Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

### 7. Handling and Storage

**Handling**

Pressurized container: Do not pierce or burn, even after use. DO NOT handle, store or open near an open flame, sources of heat or sources of ignition. Protect material from direct sunlight. Do not smoke while using or until sprayed surface is thoroughly dry. Use only in area provided with appropriate exhaust ventilation. Do not use if spray button is missing or defective. Do not re-use empty containers. Avoid breathing dust/fume/gas/mist/vapors/spray. Avoid contact with skin. Avoid contact with eyes. Wear personal protective equipment. Avoid prolonged exposure.

**Storage**

Contents under pressure. Do not puncture, incinerate or crush. The pressure in sealed containers can increase under the influence of heat. Keep away from heat and flame. Do not expose to heat or store at temperatures above 120°F/49°C as can may burst. Avoid exposure to long periods of sunlight. Store in a well-ventilated place. Keep away from food, drink and animal feedingstuffs. Level 1 Aerosol (NFPA 30B)
